#### Description

1. The Tarlac State University, through Special Budget (SB) 2024 intends to apply the sum of Eleven Million Six Hundred Ninety-Four Thousand Nine Hundred Thirty Four and 77/100 Pesos (₱ 11,694,934.77) to payments under the contract for the project: Completion of Fire Protection System at CTED Building.

Quotations received in excess of the ABC shall be automatically rejected at bid opening.

2. The TSU Bids and Award Committee (BAC) now invites technically, legally, and financially capable contractors for the said project. Completion of works is required within 180 calendar days from the issuance of Notice to Proceed.

3. The Procurement procedure for this requirement is Negotiated Procurement for Two Failed Bidding pursuant to Section 53.1 of 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

The selection of the successful offer shall be based on the best and final offer that will be submitted on the set deadline by the BAC.

4. The interested bidders may obtain further information from the BAC Secretariat at the address given below from November 12, 2024 to November 26, 2024, Tuesday to Friday, at 8:00AM to 5:00PM.

5. The TSU-BAC will hold a Negotiation Meeting on November 19, 2024 at 9:00 A.M., at BAC Conference Room, 3rd Floor, Motorpool and Administration Building, Tarlac State University, Romulo Blvd., San Vicente, Tarlac City, which

shall be open to prospective bidders.
